4. NAAC Reaccreditation Process

The main concern of the college is to get NAAC reaccreditation as soon as possible. Dr.K.H.Yadav and Dr.G.S.Patel(IQAC Coordinator) gave the status report of the NAAC process. Query was raised by the College on NAAC portal regarding the AOAR (2022-23) and duration of NAAC –SSR. NAAC gave their reply so college will submit the AQAR (2022-23) in the first week of July, 2023. IQAC committee finalize the deadline of SSR submission and it will be 30th September, 2023. College Principal, IQAC Coorodinator and IQAC teaching faculty member gave assurance to the IQAC committee to submit SSR by 30th September, 2023. Dr. Nerlekar suggested that each criteria wise discussion will be conducted between 15th -20th September at AES office prior to submission of SSR.

5. Annual Activity Report

Dr. Yadav presented the annual activity report. Committee members suggested to identify the pedagogy related activity under the banner of CPI. Dr.Nerlekar suggested the Climate Change Activity should be arranged for the faculty of AES Colleges also.
