- **Approval of Ordinance, Rules, Regulations, and Credit Framework**

Patel** presented the modified curriculum framework – Credit Framework in accordance with the Gujarat University B.Ed. Program. ## Rechecking: (Maximum Two courses)

Rechecking procedure will primarily focus on verifying the accuracy of marks. It will ensure that all answers were evaluated, there are no calculation errors in totaling marks, and the final score is correctly entered. Student Teachers can apply for rechecking for maximum of two courses.

## Re-evaluation (Maximum Two courses)

It was unanimously decided that in re-evaluation process, the paper will be reassessed by the Examiner-2 (Reassessment) and if difference in marks between Examiner-1 (Original Examiner) and Examiner-2 (Reassessment) is not more than 10% then marks given by Examiner-1 (Original Examiner) will be considered as final.

But, in case, the difference of marks between Examiner-1 (Original Examiner) and Examiner-2 (Reassessment) is more than 10%, the paper will be given to Examiner-3 (Reassessment) for assessment. In such case, average marks of all three examiners will be considered as final marks. Detailed process of Reassessment will be placed in Rules & Regulations.

## There is no reassessment process in Practical Examination.

The members collectively reviewed the proposals and provided constructive feedback. Modified credit framework with ordinance and rules and regulation was approved.

**Dr. K.H. Yadav** expressed sincere gratitude to all members for their valuable contributions and active participation. The meeting concluded with a vote of thanks.
